

PRIVACY STATEMENT - SILVERHILL PRODUCTION KFT.

General Data Management Guidelines

The Silverhill Production Kft. (hereinafter: Silverhill) as the operator of the www.silverhill.hu website manages personal data collected or recorded during its activities based on the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC and on Act CXII of 2011 on information self-determination and freedom of information, as follows.

Detailed information other than the general guidelines:

Data processing details for the website www.silverhill.hu:

During your website visit the responsible data processor of your data is the Silverhill.

With your visit to the Internet site of the Silverhill you also submit your personal data to us.

Your personal data (data relating to you) may enter into our processing in the following ways: on the one hand technical data referring to your computer, browser software, Internet address, and the pages visited are automatically generated in our IT systems as a part of keeping the Internet connection alive; on the other hand you may give us your name, contact details or other information if you wish to contact us during the website use session.

The information available on our website does not require you to log on or provide your credentials for access. However, there are certain functions (email contact) that may require you to provide certain personal information (name, email address). (*Contact/Email/Write us*)

If you provide any of your personal data to the Silverhill, by that you give your consent to the Silverhill to keep on record and process these data, for the purpose and duration specified by the type of the transaction.

The Silverhill shall never divulge the data disclosed to it during the use of its website to any third party under any circumstances, with the exception of the cases defined by law.

The Silverhill does not use the services of external entities (data processing agents) for the operation of the website, including the handling of the data of visitors.

The Silverhill shall treat data of a personal nature provided by you through the Internet with the same level of security protection as the protection of data provided by other means.

Your rights affecting data protection:

You can enforce your access to the data at any time. In addition, as long as their terms are met, you may also exercise the rights listed below:

- Right to rectification
- Right to erasure ("right to be forgotten")
- Right to restrict the processing of personal data
- Right to complain to the competent data protection supervisory authority (contact information : www.naih.hu)
- Right to information and right to access (beginning from May 25th 2018)

Right to protest:

You, as subject to data handling may object anytime against the data handling based on legitimate interests of the Silverhill. Silverhill will immediately terminate the data handling concerned unless Silverhill demonstrates that the data management is justified by legitimate reasons which have priority over the interests, rights and freedoms of the party concerned, or which relate to the submission, enforcement, or defense of legal claims.
